NON-REFUNDABLE REGISTRATION FEE

New Students - Beginning March 1

Early Childhood \$40 K-12 \$185

Alumni Discount: Registration fee waived for new students who are children of LCCS, LCS, or LWA graduates.

Full-Price Application Fees will be applied to the first two children per family. Each additional child is \$15.

Reenrolling Students - Beginning February 1

Early Childhood \$40 K-12 (February discount) \$85

K-12 (beginning March 1) \$160

Full-Price Reenrollment Fees will be applied to the first three children per family. Each additional child is \$15.

A LA CARTE CLASSES

Homeschool families may take up to three individual classes through LCCS (as available). LCCS assumes all responsibility for instruction and grading and will send grade reports to parents to include in their homeschool documentation. Enrolling in two core classes (full year) allows participation in Fine Arts extra-curriculars and middle school athletics (\$150/activity or \$295/year).

FINANCIAL ARRANGEMENTS

Multi-Child Discount: (For grades K-12 only)	Beginning with the highest tuition: Deduct 5% for second student, 10% for third student, and 15% for each additional student.
Referral Credit:	Referring family (already an LCCS family) earns a tuition credit for each first-time family that enrolls at least one student in grades K-12 and completes at least one quarter. Awarded as a \$500 tuition credit November 1.
EITC Referral Credit:	Referring family earns \$250 when EITC donation is received.
Payment Options:	All payments will be handled by FACTS. Payment plans are selected as part of the enrollment process. Pay by preauthorized debit to a checking or savings account, or credit card. <ul style="list-style-type: none"> • Pay in full in July. • Two payments – July and January. • Ten payments – July through April • Eleven payments - July through May • Twelve payments – July through June
Non-Sufficient Funds (NSF):	\$30 per direct debit not honored by the bank.
Late Fee:	\$20 per month will be assessed for tuition payments that are 15 days past due.
Early Withdrawal:	Fee for early withdrawal is \$100 for each incomplete quarter, maximum \$400. International students are required to pay one full semester of tuition.
Delinquent Accounts:	Students whose tuition is more than 30 days in arrears at the end of any marking period may be asked to withdraw.

SCHOLARSHIP INFORMATION

All scholarship eligibility is determined by FACTS Grant & Aid Assessment. An application may be completed online using the link from our website (lccs.cc). The application, along with required documentation and payment, should be completed online by April 15, 2018.

These guidelines are firm for EITC funds; special circumstances will be considered for LCCS-provided scholarships.

The enrollment process must be completed before the scholarship award can be determined, but the scholarship application should be submitted to FACTS as part of the enrollment process. This is important because additional information is sometimes requested, causing processing to be delayed.
